## ASIL Midyear Meeting October 19 – 21, 2012 Atlanta and Athens, Georgia

The American Society of International Law's third annual Midyear Meeting and Research Forum, hosted by ASIL Academic Partner University of Georgia School of Law, will be held **October 19-21, 2012**, in Atlanta and Athens. The Midyear Meeting and Research Forum are for legal practitioners, scholars, judges, and others interested in international law.

This year's meeting will consist of a CLE program and reception for practitioners in Atlanta on Friday, October 19 titled, "When Transnational Business Deals Go Sour: The Challenges and Opportunities of International Arbitration." Focusing on recent developments in the field as well as real-world case studies of arbitration's success and failure, the program will be moderated by Glenn Hendrix of Arnall Golden & Gregory and will feature a panel of distinguished practitioners and academics in the field:

On October 20-21, the meetings move to Athens for Society leaderships meetings, a career fair, keynotes, and the Research Forum for discussion of academic works-in-progress.
